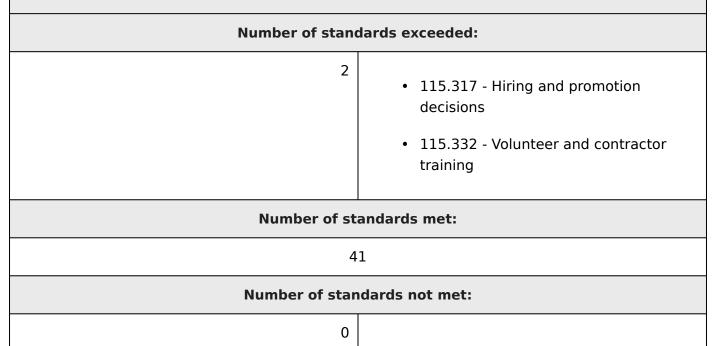

### 115.313 Supervision and monitoring

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

Regarding 115.313 (e) Each secure facility shall implement a policy and practice of having intermediate-level or higher-level supervisors conduct and document unannounced rounds to identify and deter staff sexual abuse and sexual harassment. Such policy and practice shall be implemented for night shifts as well as day shifts. Each secure facility shall have a policy to prohibit staff from alerting other staff members that these supervisory rounds are occurring, unless such announcement is related to the legitimate operational functions of the facility.

Supervisor and/or mid-level management rounds are conducted throughout the facility and notated on a shift log that has been reviewed by the auditor. However, knocking on the door prior to entry is standard procedure, or at least the widely used practice, for all staff, which brings into question how any type of round could be classified as unannounced since staff and youth are alerted to someone entering for virtually all housing unit visits.

Supervisors and managers should have some fully unannounced, documented rounds to check in on the housing units, staff, youth and young adults.

This Standard was found to be non-compliant during the initial audit and documented in the interim report.

During the Corrective Action Plan visit on February 9th, 2024, the auditor finds that the facility has implemented processes to ensure that there are announced rounds termed "PREA checks" within each of the housing facilities. These are documented with both a checklist within the housing unit and within a daily "SPC" log that is held in the control room.

These unannounced rounds are directed to occur at least twice during an 8 hour shift. The doors to the housing units remain open at night. The auditor also interviewed residents, line staff, and a supervisor. All indicated that these unannounced rounds are occurring.

The auditor has reviewed logs for four weeks to ensure that this practice is in place. The facility has minimum staffing requirements and a mandatory overtime to meet the required levels. Additionally, the facility ensures that two staff are always with any youth. The facility utilized their PREA Review Board to ensure that their staffing plans are adequate for prevention and response to any PREA related incident.

The findings during follow up visit find the facility compliant with this Standard.

### 115.315 Limits to cross-gender viewing and searches

**Auditor Overall Determination: Meets Standard** 

### **Auditor Discussion**

In regard to 115.315 (d): The facility shall implement policies and procedures that enable residents to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. Such policies and procedures shall require staff of the opposite gender to announce their presence when entering a resident housing unit. In facilities (such as group homes) that do not contain discrete housing units, staff of the opposite gender shall be required to announce their presence when entering an area where residents are likely to be showering, performing bodily functions, or changing clothing.

Knocking on all doors may have created an expectation that signals someone is coming into the housing unit, instead of using it to message and alert that opposite gender staff is entering the pod/housing unit. This practice of knocking and announcing upon entry would be a sound practice if it had only opposite gender present meaning, but it appears that it is utilized universally. Through interviews with staff and residents, it is apparent that the announcing occurs "most of the time", but staff knock regardless of the gender entering the unit.

The auditor and non-certified auditor staff thoroughly toured the facility and assessed areas for privacy and documented camera angles. Multiple random staff and youth interviews were conducted that were consistent with privacy being a priority for the facility. The agency does not do cross-gender strip searches.

The auditor revisited the facility on February 9th, 2024 to assess the progress on the Corrective Action items. The auditor interviewed the PREA Manager for the facility and reviewed a survey that was used as a refresher training for the staff at the facility. The survey posed scenarios of how a housing unit may be staffed and whether it needed a knock and announce for the opposite gender entering. The facility focused the survey quiz for when they should alert residents to a change in the status of the gender of the staff member overseeing the housing unit: Announcing with the entry of another staff member of a different gender than was already there. The staff received high scores for the survey quiz, with many of the

staff receiving at or nearly 100% on the questions surrounding this Standard.

Staff and residents were interviewed about the practice of announcing for opposite gender or status change. The interviews yielded information that staff has put this into practice and it is becoming part of the culture of the facility.

It is determined that the facility is compliant with this Standard.

### 115.316

### Residents with disabilities and residents who are limited English proficient

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

115.316 (b): The agency shall take reasonable steps to ensure meaningful access to all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment to residents who are limited English proficient, including steps to provide interpreters who can interpret effectively, accurately, and impartially, both receptively and expressively, using any necessary specialized vocabulary.

While the facility has a contract with an interpreter service, youth or staff could not demonstrate it, find the number for a language line or provide the procedure for its use. Appropriately, the facility does not use resident/youth interpreters, but utilizes county staff if needed; however, this practice does not allow youth to anonymously report as they don't have access to an interpreter service.

It was determined that the facility is not compliant with this Standard at the time of the Interim Report.

The auditor visited the facility to follow up on Corrective Action items on February 9th, 2024.

During this visit, the auditor observed signs in the housing units and clinic, advising residents and staff of the availability of a translator service, including the sign-in instructions. The auditor interviewed staff about their knowledge of how to obtain an interpreter. In one case, a staff member was grateful for the additional information and found it helpful. All now had general awareness of how to contact an interpreter for any language. The auditor also obtained a directive memo that was sent to all staff for awareness and a reminder of this particular PREA Standard.

The facility is determined to be compliant with this Standard.

### 115.317 Hiring and promotion decisions

### Auditor Overall Determination: Exceeds Standard

### **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated.

In regard to this Standard, the agency was observed to go above and beyond having the PREA auditor and non-certified auditor assistants take the facility's PREA training and subjected them to a Live-Scan background before they were granted access to the facility and its youth and young adults.

Since the State of California DOJ does not permit the use of the Child Abuse Central Index (CACI) for any staff except sworn, a recommendation to continue their current background processes for their non-sworn and contractors. In addition to this recommendation, HR was also advised to consider utilizing the web-based Megan's Law website as an additional screening tool for awareness of those who are registered sex offenders.

Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to **exceed** the elements of this Standard.

### 115.318 Upgrades to facilities and technologies

**Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

**Recommendation:** Cameras of "Phase II" in older sections of the Ranch, including the culinary arts building, has walk-in refrigerator/freezer and storeroom. Youth/ young adults and staff have access to these enclosures, but there are no cameras whatsoever. Cameras do not necessarily need to be inside them, but it would be helpful if one could see the view outside to know that staff and youth do not enter these rooms together.

Finally, the auditor finds that the recording of the current cameras is not yet authorized by the County. The auditor strongly recommends that this practice is approved and enacted as soon as possible to provide additional tools in preventing, detecting, and responding to allegations of sexual assault and sexual harassment in the facility.

Upon revisiting the facility during the corrective action period, the auditor learned and was provided with documentation that the recording policy is now authorized and is being implemented on the current camera system. Funds for additional cameras in the older section of the Ranch have been requested.

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated.

Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

# Auditor Overall Determination: Meets Standard Auditor Discussion A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. The auditor spoke with a Sergeant at the Morgan Hill PD to understand their response and follow up relationship with the facility. Also discussed the renewed crisis reporting contract (YWCA) and sought clarification on mandatory reporting on behalf of youth that are not minors, but are in custody and considered youth/young adults. Following the comprehensive review, Santa Clara County's William F. James Ranch

facility is determined to be compliant with the elements of this Standard.

# Policies to ensure referrals of allegations for investigations Auditor Overall Determination: Meets Standard Auditor Discussion A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. While the facility has policy and practice in place for investigation referrals to law enforcement, there have been no criminal allegations in the 12 months prior to this audit. Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

### 115.331 Employee training

### **Auditor Overall Determination:** Meets Standard

### **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated.

The auditor has reviewed training curriculum and interviewed staff to assess their understanding of the materials. The facility tracks the staff who have been trained utilizes the records to conduct refresher on a regular schedule.

Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

### 115.332 Volunteer and contractor training

Auditor Overall Determination: Exceeds Standard

### **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed.

Exceeds: The facility included the PREA auditor on their agency mandatory contractor training prior to allowing the auditor to have contact with youth. The facility has documented the training for each contractor and tracks when refresher training is due.

Facility practice and culture has been observed and evaluated.
Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to exceed the elements of this Standard.

### 115.333 Resident education

Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. Youth receive the information throughout their time in custody, including

at intake through video and written materials.

Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. The agency/facility uses information from the risk screening required by §115.341 to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse. Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

# Auditor Overall Determination: Meets Standard Auditor Discussion A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. The facility has multiple ways to report. This was confirmed in viewing signage throughout the facility, verifying the YWCA contract and working phone number, interviewing staff and youth who understood the multiple ways to report. Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

## Resident access to outside confidential support services and legal representation

**Auditor Overall Determination: Meets Standard** 

## **Auditor Discussion**

115.353 (a): The facility shall provide residents with access to outside victim advocates for emotional support services related to sexual abuse, by providing, posting, or otherwise making accessible mailing addresses and telephone numbers, including toll free hotline numbers where available, of local, State, or national victim advocacy or rape crisis organizations, and, for persons detained solely for civil immigration purposes, immigrant services agencies. The facility shall enable reasonable communication between residents and these organizations and agencies, in as confidential a manner as possible.

The auditor observed a log in the nurse's office for the "Red Phone". This phone is a phone that does not have a keypad, but directly dials the YWCA, which is the contracted, qualified crisis line. The observed phone use log is inclusive of the date, time, and who used the phone. A discussion with the on-duty nurse disclosed that the nurse follows up with those that use the phone, in an effort to help. The nursing staff attempts to learn how they might assist the youth or young adult, to get them the resources needed. This practice potentially strips the caller of the confidentiality requirement if the youth is desiring to keep their matter private.

Additionally, it is further recommended that staff help eliminate stigma associated with the use of the phone. In one allegation reviewed, staff openly asked a youth/ young adult if they needed to use the "red phone" after they made an allegation, effectively indicating to those around that the resident may be a victim of a sexual harassment or assault.

Finally, while the auditor and assistant were able to get through to YWCA immediately on the red phone in the nurse's office, it should be noted and communicated that during afterhours and weekends, the caller would need to speak prompts, since the phone itself does not have any keys on it. The auditor learned that during off hours, the line goes to a call routing system that is not directly to the crisis worker. The caller will need to press or speak "9" to get to a worker. Speaking "9", instead of pressing a key was tested and worked as designed.

Initially it was determined that the facility does not meet this Standard.

The auditor revisited the facility on February 9th, 2024. The facility has taken steps and implemented policy and practice to ensure confidentiality for residents utilizing the "red phone". It is widely promulgated within the facility that the phone is for any type of crisis counseling, not only for reporting sexual assault of abuse. The RN who manages the clinic has received a memo from the facility management to only log the number of residents using the phone. Furthermore, the Crisis Phone Log beginning January 2024 reflects only the a tally of how many residents have or will use the phone, with no name or purpose recorded on in the log.

It is determined that the facility is compliant with this Standard.

## 115.354 Third-party reporting

Auditor Overall Determination: Meets Standard

## **Auditor Discussion**

115.354 (a): The agency shall establish a method to receive third-party reports of sexual abuse and sexual harassment and shall distribute publicly information on how to report sexual abuse and sexual harassment on behalf of a resident. Signs and other materials direct youth for various methods of reporting.

In regard to this Standard, the auditor interviewed a crisis center worker who advised that they are a mandatory reporter for those under 18. However, this juvenile facility houses young adults who can be up to 26 years old. This creates a gap in reporting a sexual crime that has occurred involving the young adult. In this scenario, the Santa Clara Probation Department, James Ranch is the guardian of the young adult and authorities should be notified of the crime.

It is determined that the facility initially did not meet this Standard.

The auditor returned to the facility on February 9th, 2024 to review the corrective action items. The facility administration has renewed the expired contract with the YWCA, the third party agency utilized for reporting sexual assault or abuse. The management of the facility has also sought clarification with YWCA and language

within the contract that states that they report on behalf of a "child". The facility management has received in writing from YWCA that they will report on behalf of anyone in a juvenile facility. The facility QA staff have developed a schedule to check in with the call-takers at the YWCA monthly, to ensure that they will report for anyone in the facility. The QA staff calls the crisis number and asks the call agent that answers if they would report for anyone in the facility, or only a child.

It is determined that the facility is in compliance with this Standard.

## 115.361 Staff and agency reporting duties

Auditor Overall Determination: Meets Standard

## **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. Based on a reviewed incident, staff report immediately. Multiple staff were interviewed and stressed their obligation to report immediately.

The agency requires all staff to report immediately and according to agency policy any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is part of the agency.

Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

## 115.362 Agency protection duties

Auditor Overall Determination: Meets Standard

## **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. When the agency or facility learns that a resident is subject to a substantial risk of imminent sexual abuse, it takes immediate action to protect the resident. Staff interviews revealed that they have an obligation to immediately protect youth in this situation.

Following the comprehensive review, Santa Clara County's William F. James Ranch facility is determined to be compliant with the elements of this Standard.

## **Recommendation:**

Have a plan and contingencies communicated for female youth/young adult if in imminent danger of being abused.

Some staff interviewed were uncertain what they would do, although all said to remove her from the housing unit and probably send her to Juvenile Hall. While that is one sound way to protect, by giving the potential victim her own room, the facility should consider if going to juvenile hall or going to isolation is punitive, especially if the female is a trans-female.

# 115.363 Reporting to other confinement facilities Auditor Overall Determination: Meets Standard

### **Auditor Discussion**

A review of policy, practices, and supporting documents has been conducted. A thorough on-site tour has been conducted. Staff, contractors and partner agencies have been interviewed. Facility practice and culture has been observed and evaluated. The agency has a policy requiring that, upon receiving an allegation that a resident was sexually abused while confined at another facility, the head of the facility must notify the head of the facility or appropriate office of the agency or facility where sexual abuse is alleged to have occurred. The agency has not had a recent matter matching this situation, but the policy is compliant and includes ensuring this report is completed within 72 hours. An interview with the facility administrator confirms that they would report this immediately.

While the "red phone" is a great resource for reporting, some staff interviewed believe that it is policy that a youth needs to utilize the phone if they are alleging an sexual harassment. Those that don't believe it is policy, they believe it should be suggested to the alleging youth/young adult.

This is somewhat counterintuitive. Should an allegation be received by staff, they have policy and procedure to escalate the complaint to management, management has demonstrated that they refer the allegation for investigation. Calling the crisis center can get the reporting party an advocate and will report the situation for investigation, however the referral for investigation should already be under way, and staff should be asking if the youth/young adult would like crisis support without them needing to call for it themselves.
